Dear Residents,

You spoke; they (Brent Council) listened.

We have two important updates for this month.

One Tree Hill Open Space

At our public meeting on 19 March, many residents from the area complained about anti-social behaviour, drinking in public, mopeds riding through the parks, brawling amongst gangs and drug dealing.

WCARA will be working with residents and keeping this high on our list of priorities. Residents of Braemer Avenue and WCARA held separate meetings to outline our concerns and discussed proactive solutions to deal with issues highlighted.

Brent Council together with Safer Neighbourhood Teams have taken actions to deal with offenders. Here are some outcomes from the enforcement rounds carried out on the weekends of 27/28 April and 4/5 May:

- 1. 5 Public Space Protection Orders (PSPO) under the Anti-Social Behaviour, Crime and Policing Act 2014.**
 - 2. 2 x business duty of care**
 - 3. 1 case of licensing, business operating out of vehicle**
 - 4. 14 fixed penalty notices**
 - 5. 3 fixed penalty notices for urinating**
 - 6. 2 fixed penalty notices for spitting at entrance of park and playground**
 - 7. 5 Cannabis warnings – All individuals on cannabis warnings will be referred to the Wembley Joint Action Group meeting for further offender management.**
 - 8. 7 x PSPO street drinking warnings**
 - 9. Removal of graffiti near entrance of Bridgewater Road**
 - 10. 3 x weekly pick up of litter from One Tree Hill**
